1. Unfavorable references.
2. Prior documented incidents at OPAA and or any athletic association.

**Criteria for immediate rejection of application.**

1. Any criminal offense related to abuse, neglect, or exploitation
2. Lewd or lascivious behavior, molestation, or inappropriate behavior with a minor
3. Battery or aggression
4. Domestic violence
5. Drug use or possession charges
6. DUI resulting in inappropriate behavior
7. Any felony conviction
8. Conviction under any other statute that would indicate an individual is unsuitable for a position with trust of a minor

Application approval does not guarantee specific placement of volunteer. Applicant participation may be limited due to past history of suspension or issues at OPAA. All applicants will be confidentially screened and maintained thru our screening committee process. Any applicant that is rejected thru this process will have the right to a confidential appeal by the screening committee.
